NEW STUDENT SCHOLARSHIP APPLICATION

Requirements:

Student must be an enrolled member of the Seneca-Cayuga Tribe of Oklahoma, enrolled in an accredited college or university, or an accredited trade or vocational training school and be able to provide proof of satisfactory performance in the college, university, trade or vocational training school or high school attended. Satisfactory performance shall be defined as: maintaining a 2.0 GPA in the course of study. A full time student shall be defined as: enrolled in no less than 12 semester class hours during the spring or fall school term, and no less than 6 semester class hours during the summer school term.

For applicants attending an accredited trade or vocational training school, full time shall be defined as: the number of hours required to complete the course of study. An applicant for graduate assistance shall be defined as: enrolled in a minimum of 9 semester class hours during the spring or fall school term and in a minimum of 3 credit hours during the summer school term. A completed application package must be submitted to the Claims Committee for each semester of continued enrollment. To remain eligible for continuing scholarship funds from the Seneca-Cayuga Tribal Scholarship Fund, students must remain in good standing with the programs specific hour requirements and maintain no less than a 2.0 grade point average (GPA).

Filing Deadline:

Fall Semester – September 15th
Spring Semester – January 15th
Summer Semester – June 15th

A Student filing an application with the Claims Committee for the first time is considered a new student. A completed application package will be reviewed and processed at the time received. Applications will not be considered complete unless the student submits the following:

1. Completed application form, signed and dated.
2. Copy of Tribal membership card.
3. Proof of enrollment or acceptance of enrollment on school letterhead.
4. Semester class schedule must be attached.
5. Transcript of last school attended, or a copy of GED scores.
6. Statement of Understanding; signed and dated.
7. Permission for Release of Information Form; signed and dated.

Use of Education Funds:

Tribal Scholarship funds are a supplemental source of aid for qualified students and will be paid directly to the student and may be used for the educational needs of the student.
